## Co-op Credit Union Ranked #1 in the Nation

Callahan & Associates, an independent credit union analyst, recently shared their Return of the Member (ROM) results for all national credit unions. The results rank Co-op Credit Union #1 in our peer group! Return of the Member measures the value a member receives through rates received on savings, rate savings on loans and the credit unions product penetration.

"Our top ranking is quite an accomplishment and truly shows how well we are serving our members and

maintaining our mission as we continue to grow," said Eric Chrisinger, CCU Ambassador. "If we forget who we work for, we're in trouble!"

Co-op Credit Union's peer group consists of 286 other credit unions within the same asset size range of \$500 million to \$1 billion. This is the third time CCU has been ranked first compared to their peers and is one of four Wisconsin credit unions listed in the top 100.

This is seen in many ways, including monetary donations, event sponsorships or participation and volunteer opportunities.









Jayme has been with CCU since 2018 as a Mortgage Lending Officer and Manager and has 25 years of lending experience.


